GLOT, in just about any masonic activity listed such as holding office, voting, conferring degrees, etc., a member must be in good standings and not have masonic charges pending. I am not going to discuss pending masonic charges at this time but concentrate on good standings. So what constitutes a member "in good standings"? Title II, Chapter 18 explains the subject and the ramifications, but basically a brother is in good standings if dues are paid for the current calendar year of January 1 through December 31 unless otherwise exempt (Art. 319). After January 1st, the WM may appoint a Committee on Arrears to contact the Brother

In reading the through the law book of the and encourage him to pay his dues. If this fails, the committee may recommend suspension (Art. 319a). If the Brother fails to pay dues by June 23rd of the masonic year, he will automatically be suspended and shall be reported to the Grand Secretary (Art. 320). This has the effect of a suspension for un-masonic conduct, but upon paying dues owed, the Brother is reinstated (Art. 323) unless the suspension has lasted for three years then the Brother may be expelled (Art. 326) and must apply for reinstatement (Art. 327).



Gädieke says that, "according to the ancient laws of Freemasonry, man, with bonds of love." every brother must attend his Lodge if he is within the length of his cable tow." The old writers define the length of a cable tow, which they sometimes called a cable's length, to be three miles for an Entered Apprentice. But the expression is really symbolic, and as it was defined by the Baltimore Convention in 1842, means the scope of a man's reasonable ability.

The Cable Tow is thus a symbol of the cord of bond of Love, which should unite the whole fraternity. Its length or the length of your Cable Tow is the sacrifice you are willing to make on behalf of your brethren. It is in your heart, not to be measured by miles. It is not gauged by distances, but by deed. It should correspond to the immensity of the monitorial lodge, and to do so should span the earth, touching wherever there is sorrow or
